Purpose of this form

Use this form to apply to CASA for a special flight authorisation to allow the operation of foreign registered aircraft within Australian territory that does not have a standard certificate of airworthiness required by subparagraph 91.965(1)(b)(ii) of the *Civil Aviation Safety Regulations 1998* (CASR) or is operating under a special flight permit (however called) issued by a foreign National Aviation Authority (NAA).

Who is this form for?

This form is for the operator of a foreign registered aircraft that has a special certificate of airworthiness or a special flight permit (however called) who wishes to operate in Australian territory.

In accordance with the Chicago Convention (Annex 8), Australian legislation requires aircraft operating in Australian territory to have a valid standard certificate of airworthiness. Foreign aircraft with the equivalent of a special certificate of airworthiness or a special flight permit, require a special flight authorisation.

Information needed to complete this form

You should review CASR Subpart 91.Z - Foreign aircraft before completing this form.

To progress your application a 'yes' response is required to one of the questions in 5-8.

After receiving a completed application form and the **supporting documentation specified throughout this application**, CASA will calculate and send you a cost estimate for the processing of your application and a list of any additional supporting documents required. You will need to **pay the estimate and send any outstanding supporting documentation** with your payment before the assessment of your application occurs.
