### Purpose of this form

Use this form to notify CASA that your organisation is ready to transition to the training and checking system requirements of the new flight operations regulations Parts of *Civil Aviation Safety Regulations 1998* (CASR) in accordance with CASA EX87/21.

### Who is this form for?

This form is for all AOC holders who conduct air transport operations under Parts 133 or 135 of CASR, and/or hold a Part 138 Aerial Work Certificate that **requires** a Training and Checking System (T&C system).

CASR 119.170 requires all air transport AOC holders to have a training and checking system.

CASR 138.125 requires Aerial Work Certificate holders to have a training and checking system when performing these operations:

- transporting marine pilots
- NVIS
- using offshore airborne radar approach procedures in accordance with section 8.6 of MOS Part 173 (Helicopter off-shore procedures – airborne radar)
- using descent and operational procedures for:
  - rotorcraft IFR flight and VFR flight at night (MOS 138.9 D3)
  - rotorcraft IFR flight that is a SAR operation involving an autohover using transition mode capability over the sea (Div 5 of Chap 9 of MOS Part 138)
  - aeroplanes IFR flight below minimum height over the sea (Div 4 of Chap 9 of MOS Part 138)
- using a multi-engine rotorcraft with MTOW above 3,175kg that is type certificated in the restricted category
- using a multi-engine rotorcraft with MTOW above 3,175kg that is type certificated in the transport category
- using turbine-engine aeroplanes (other than turbine- engine propeller-driven aeroplanes)
- using multi-engine aeroplanes with a MTOW of more than 5,700kg
- for the purpose of training or checking air crew members under the MOS 138.24.

Your submission must include:

- this form signed by your Chief Executive Officer (CEO) or agent under a Power of Attorney for the CEO
- proposed exposition/operations manual containing content for key personnel and T&C system,

- if previously submitted, provide the version number of the exposition/operations manual containing the T&C System content used to conduct the self-assessment
- completed self-assessment worksheets relevant to all Parts of the regulations under which you operate that require a T&C system
- name of the approved Head of Training and Checking (HOTC), or a nomination for HOTC
- name of the approved alternate HOTC or nomination for alternate HOTC (see note)

**Note:** Section 16 of CASA EX 82/21 exempts an operator from compliance with subparagraph 119.205(1)(e)(iv) unless the operator chooses to name, in the exposition, a person who is authorised to carry out the responsibilities of a key person when the position holder is absent from the position, or cannot carry out the responsibilities of the position (sometimes colloquially termed 'alternate' or 'standby' HOTC).

This form will use the term 'Alternate HOTC'.
