Purpose of this form

This form is used by pilots to request recognition of firefighting operations prior to 1 September 2014.

Who is this form for?

This form is to be used by pilots to apply for the grant of an Aerial Application – firefighting endorsement.

Information needed to complete this form

To be granted an **aeroplane** firefighting endorsement, you **must** meet the following requirements:

- hold, or be taken to hold, a *Civil Aviation Safety Regulation 1998* (CASR) Part 61 aerial application rating, which is equivalent to a CAR Part 5 agricultural pilot (aeroplane) rating
- prior to 1 September 2014, have undertaken firefighting operations training provided by the operator in accordance with its operations manual
- prior to 1 September 2014, have conducted firefighting operations in an aeroplane

To be granted a **helicopter** firefighting endorsement, you **must** meet the following requirements:

- prior to 1 September 2014, have held the minimum qualifications for water dropping by a helicopter engaged in firefighting operations in accordance with CAO 29.5 (as in force prior to 1 September 2014)
- prior to 1 September 2014, have conducted firefighting operations in a helicopter
- prior to 1 September 2014, have undertaken firefighting operations training provided by the operator in accordance with its operations manual
- If the licence holder does not currently have a CASR Part 61 licence document, they must submit [Recognition and Transfer CAR Part 5 Qualifications \(Form 61-9TX\)](#).
- If CASA does not have a photo of the licence holder that is less than 10 years old, they must also submit [Lodgement of current photo with CASA \(Form 61-9PIC\)](#).

Aviation Reference Number (ARN)

An ARN is required to complete this form. If you do not have an ARN, [apply now](#).
